#### \*Important Notice

#### **Assessment Conditions**

- 1. Ensure assignments are done by students in a controlled environment.

#### **DEFINITIONS**

Total Qualification Time (TQT) is the number of notional hours which represents an estimate of the total amount of time that could reasonably be expected to be required in order for a Learner to achieve and demonstrate the achievement of the level of attainment necessary for the award of a qualification. Total Qualification Time is comprised of the following two elements — a) the number of hours which an awarding organisation has assigned to a qualification for Guided Learning, and b) an estimate of the number of hours a Learner will reasonably be likely to spend in preparation, study or any other form of participation in education or training, including assessment, which takes place as directed by — but, unlike Guided Learning, not under the Immediate Guidance or Supervision of — a lecturer, supervisor, tutor or other appropriate provider of education or training. (Ofqual 15/5775 September 2015)

Guided Learning Hours (GLH) is defined as the hours that a teacher, lecturer or other member of staff is available to provide immediate teaching support or supervision to a student working towards a qualification. Credit value is defined as being the number of credits that may be awarded to a Learner for the successful achievement of the learning outcomes of a unit. One credit is equal to 10 hours of TQT

#### Career Goals

Throughout the creation of the credentials, discussions and input on content, the potential learner audience for the qualification, and evaluation methods were conducted to ensure that a valuable experience and a recognized collection of skills, expertise, and understanding were realized.

Partner Centres are recommended to have a career guidance and counselling department set up so students can gain knowledge on career options and industry orientated skills required for employment opportunities. We aim to provide less educated students without proper qualifications an opportunity to gain a proper qualification.

Students must have a healthy balance between their academic studies and extra-curricular activities to progress further in their career goals; through a range of course specific tasks, workshops and meetings with individuals of industry.

## Recognition of Prior Learning

RPL is a form of evaluation (leading to credit) that considers whether learners can show that they already have the expertise, understanding, or skills needed to fulfil the assessment criteria for a unit and therefore do not need to improve them via a learning program.

EDUK helps centres to recognize students' past accomplishments and interactions outside of the classroom, whether at work, at home, or in their spare time. RPL is a framework for understanding the accomplishments that come through lifelong learning.

RPL allows accomplishment to be acknowledged through a wide variety of activities using any appropriate evaluation technique. The use of RPL for accrediting a unit, units, or a whole qualification is permissible as long as the assessment criteria of a given unit or qualification are met.

Valid and reliable proof of learning is needed.



#### Aims of the Diploma

The program's aim is to provide a career path for students who want to improve their core competencies in this field. Learners can acquire the skills needed by organizations around the world as a result of the certification, which is a recognized UK qualification.

Psychology is the scientific study of the mind and behaviour. While you might understand what psychology is, many people are not quite so sure about what psychology does. What purpose does psychology serve? What are its goals?

One of the first goals of psychology is simply to describe behaviour. Through describing the behaviour of humans and other animals, we are better able to understand it and gain a better perspective on what is considered normal and abnormal. Researchers might start by observing human behaviour and then describing a problem. By understanding what is happening, psychologists can then work on learning more about why the behaviour happens and even how to change it. Imagine that researchers want to learn more about consumer behaviour. They might use market research surveys, direct observation, and other data collection methods to gather information on what people are doing when they shop. This gives researchers greater insight into what is really happening in a particular population.

Not surprisingly, another primary goal of psychology is to make predictions about how we think and act. Once we understand more about what happens and why it happens, we can use that information to make predictions about when, why, and how it might happen again in the future.

Successfully predicting behaviour is also one of the best ways to know if we understand the underlying causes of our actions.

Finally, and perhaps most importantly, psychology strives to change, influence, or control behaviour to make constructive and lasting changes in people's lives. So as you have learned, the four primary goals of psychology are to describe, explain, predict, and change behaviour. In many ways, these objectives are similar to the kinds of things you probably do every day as you interact with others



## Progression & links to other EDUK Programmes

Learners completing the EDUK Level 4 Diploma in Psychology can

#### **EDUK Quality Assurance Principles**

To be accepted as an authorized centre, all centres must go through an approval process. Centres must have trained and professional tutors on board. The tutors' expertise and willingness to support students will be crucial. EDUK and its team of Quality Reviewers/External Verifiers must be committed to working with the centres. Tutors must also participate in continuing professional development (CPD).

EDUK External Quality Reviewers (EQAs) will track approved centres to ensure that learners receive adequate learning opportunities and guidance. EQAs will request to see and address the formative evaluation plans of a centre. The suitability of these proposals will be assessed in consultation with the centre.

The EDUK guidelines on invigilation, plagiarism prevention, and conspiracy will refer to centres. Compliance will be monitored by EDUK Quality Reviewers/External Verifiers. Unless otherwise agreed, EDUK will be used for evaluation purposes.

#### **Quality Assurance Arrangements**

All centres go through an approval process to be recognised as an approved centre. Centres must have qualified and experienced staff; this will positively impact students pursuing the course.

We recommend lecturers undergo continuous professional development and monitoring the quality of the programme. Partner approved centres will be expected to have internal quality assurance principles however EDUK Qualifications will perform an external quality check.



EDUK Qualifications will provide guidance on invigilation, avoiding plagiarism and complicity between all centres and EDUK.

The Quality Assurance Team will monitor the following:

- 1. Appointed assignment creators, markers and verifiers.
- 2. The marking scheme in place
- 3. Moderation dates for assignments
- 4. Final marking and issuing of certificates

## Purpose of the Course
